Prizes:

Scholarship:

1. A \$500.00 scholarship will be presented to Miss Shrimpfest. The scholarship monies will be paid directly to the school in which the winner is enrolled.
2. The scholarship monies will NOT be paid directly to the winner of Miss Shrimpfest.
3. The scholarship must be used within 24 months of graduation from high school or within 24 months of receiving a GED. If Miss Shrimpfest does not attend college or a trade school, the scholarship is forfeited.
