1. **ABSOLUTELY NO GLASS BOTTLES WILL BE ALLOWED** within the gates of Shrimpfest.
2. **NO PETS WILL BE ALLOWED** within the gates of Shrimpfest (except Service Animals with **PROMPER PAPERWORK**)
3. No motorized vehicles will be allowed within the gates of Shrimpfest during operating hours.
4. NO vendors are allowed to stay overnight on event grounds after closing hours unless approved by Seadrift Chamber of Commerce.
5. NO refunds for inclement weather or disaster declared by the City of Seadrift, the County of Calhoun, or the State of Texas.
6. Vendors will be allowed to begin setting up between 5:30pm and 8pm Thursday June 8th, however no security will be provided Thursday night and the Seadrift Chamber of Commerce will not be responsible for and lost, stolen, vandalized, or otherwise destroyed property, electricity will not be provided to any vendor until 8am Friday June 9, 2023.
7. All vendors must check in by 9:30am Friday June 9th and be set up by 1pm as vendor gate will open at 8am for entry. Spaces will be assigned by the Seadrift Chamber of Commerce.
8. Private security will be provided Friday and Saturday nights.
9. Festival hours, Friday 4pm - midnight and Saturday 12pm - 12am. Booths must remain open until 11p.m. each day.
10. Preference areas will be given to applications in the order in which they are received. After May 12th, please contact the Seadrift Chamber of Commerce directly for availability. Submission of an application is not a guarantee of acceptance.
11. There is potable water available at ONE location on site. Vendors should make provisions to transport water or bring enough water to last the weekend. DO NOT connect to any water hose within the gates of Shrimpfest.
12. Ice will be available to purchase at \$5.00 per bag.
13. Vendors must be approved, and payment received for electrical hookup, NO EXCEPTIONS. If you are to be found using electrical hook ups without payment and approval, you will be unplugged immediately, you are welcomed to bring your own generator.
14. Vendor fee to include electricity (110v) will be issued a access tag at set up. Electricity is provided from 8am Friday to midnight Saturday.

15. Electricity provided to anyone booth may not exceed 500watts or 4amp per booth, you will only be allocated one electric plug.
16. No **ALCOHOLIC BEVERAGES** MAY BE SOLD. Vendors may sell soda, tea, etc.
17. Food Booths **MUST** be in compliance with Health Department rules and must provide proof upon request.
18. Any item deemed hazardous to others is prohibited (i.e., whips, swords, firecrackers, live animals, etc.) The promoters of this event will have sole discretion as to what may be considered hazardous or dangerous.
19. Each Vendor will receive 3 access bracelets for each day. Additional bands must be purchased for \$5.00 each. If lost or damaged, replacement bands will be \$5.00 each.
