Official Rules

1. A \$100 prize and title of **"Shrimp Eating Champion"** will be awarded to person consuming the most shrimp in the allotted time period. \$50 will be awarded to the person consuming the second largest amount of shrimp in the same time period.
2. Contestants must be at least 13 years old at the time of the contest. Contestants under age 18 must have a parent or guardian permission and signature.
3. Entry fee is set at **\$10 per entrant.**
4. Contestants will consume (and keep down) as much of the 3 lbs total allotted boiled shrimp as they can peel and eat in a three (3) minute time period.
 - Shrimp will be distributed in ½ lb. increments
 - Cocktail sauce will be provided
 - Water will be provided and ONLY water can be consumed during the contest.
7. Contest will begin when all entrants are seated and introduced. Table monitors will be stationed at the head of the tables to provide needed items and record consumption weights. After consuming an entire bag of shrimp, contestants shall begin the next bag. **CONTESTANTS MUST PLACE EMPTY BAGS IN HIS/HER EATING AREA AND RETAIN THEM FOR VERIFICATION OF FINAL CONSUMPTION TOTAL.**
8. Contestants must remain seated during the entire contest, and have had their final consumption weight recorded by the table monitor. **LEAVING YOUR SEAT BEFORE HAVING YOUR CONSUMPTION WEIGHT VERIFIED, OR FAILURE TO KEEP YOUR SHRIMP DOWN, SHALL RESULT IN DISQUALIFICATION.**
9. When the official announces the contest is over, no more shrimp may be put in your mouth or consumed by the contestant. Contestants may chew and swallow any shrimp already in their mouths. If no contestant has finished all 3 lbs., final consumption weights will be verified and a winner will be announced immediately. In the event of a tie, winners will be determined by an "overtime" contest. The "overtime" winner will be one (1) minute in length and will continue until the tie is broken, or till one of them concedes.
